Sir.

Dhanvantari Homoeopathic Medical College and Hospital & Research Centre is functional since 2000 and has submitted an application for permission for sanction of 50 seats in BHMS course for the academic year 23-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following shortfalls are noticed for immediate rectification.

- i) Teaching Faculty:
 - a. Experience certificate of Dr. Umesh, Professor, Dept. of Pharmacy is not provided.
 - b. MD degree and experience certificate of Dr. Manisha are not provided.

All the shortfalls mentioned above may rectified and the reports may be submitted in compliance report.

College is required to follow standard guidelines in the functionality as under:

- a) Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Record Room for academic purpose of students and follow up attendance of patients.
- b) Case sheets should have complete demographic details and contact details of patients.
- c) Diagnosis should be written in ICD 11 criteria

Considering the above observations, and facilities available, Medical Assessment and Rating Board for Homoeopathy has decided to issue conditional permission to Dhanvantari Homoeopathic Medical College and Hospital & Research Centre, Dhanvantari Campus, Kamatwade, Cidco Nashik, Maharasthra-422008 for conducting BHMS course for the academic year 2023- 24 with intake capacity of 50 seats. The shortfalls observed in your College

shall be rectified within a period of 30 days and compliance report shall be submitted to the MARBH failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
