After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, recommendations of the Board of Governors to CCH, permission of the Central Government is hereby granted to Dhanvantari Homoeopathic Medical College and Hospital & Research Centre, Dhanvantari Campus, Kamatwade, Opp. Abhiyanta Nagar, CIDÇO, Nashik, for continuing admissions in I-BHMS course during the academic year 2019-20 with intake capacity of 50 seats.

Sir/Madam,

I am directed to refer to the provisions prescribed under Section 12C of the Homoeopathy Central Council Act, 1973 and regulations made thereunder and Ministry's policy for the academic year 2020-21. In order to verify the compliance of availability of standards by the College, the Board of Governors to CCH has examined the documents submitted by the college authority for the admissions for the academic year 2020-21 in BHMS course of **Dhanvantari Homoeopathic Medical College and Hospital & Research Centre, Dhanvantari Campus, Kamatwade, Opp. Abhiyanta Nagar, CIDCO, Nashik**, and furnished recommendation vide its letter No. F. No. 15-8/2020-CCH (Visitation Matter) 3978 dated 03.12.2020 as under:-

"Recommended for allowing admission in BHMS Course for the session 2020-21 with the intake capacity of only 50 seats in existing UG (BHMS) course due to insufficient teaching faculties.

The Committee also recommended for apprising the Ministry about ineligible teachers; that the college website is not functional and the college has not complied with the provisions of Employee's Provident Funds & Miscellaneous Provident Act 1952 & ESI Act, 1948 and relevant Rules and Regulations. Details of ineligible teacher are as under:

- 1. Dr Manisha Anand Patil (Lecturer, Repertory) Not considered eligible as age exceeded 40 years (16-3-1976) at the time of joining (DOB- 2-Jan-2017) as Lecturer."
- 2. The college was granted an opportunity of hearing through Video-Conferencing to present their case on 29.12.2020. The college authority submitted their submissions. Upon examining those submissions, it has been observed that college is not fulfilling the minimum required criteria for grant of permission for admission on 75 UG seats..
- 2. Therefore, after considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, recommendations of the Board of Governors to CCH and report of designated hearing committee, conditional permission of the Central Government is hereby granted to Dhanvantari Homoeopathic Medical College and Hospital & Research Centre, Dhanvantari Campus, Kamatwade, Opp. Abhiyanta Nagar, CIDCO, Nashik for continuing admissions in BHMS course during the academic year 2020-21 with intake capacity of 50 seats only.

- 4. It is further informed that, minimum 15% of undergraduate seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counselling for seats under All India quota shall be conducted by respective counselling Authority of State / UT Government as designated by the Central Government vide letter F. No. L. 11011/02/2020-E- (1) dated 26.10.2020 for A.Y. 2020-21 and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the students admitted thereunder.
- 5. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under HCC Act & Regulations made thereunder. Discrepancies, if any, may be immediately brought to the notice of CCH and the Central Government.
- 6. The College shall comply with the provision for providing EPF and ESI facilities to the teaching, Non-teaching staff of the College/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
- 7. Further, the College shall comply with the procedure to get permanent registration of the Teachers,/ Hospital Clinical Staff/ Consultant in concerned State Boards/ Council where the college/ hospital is located or Central Registration of CCH as per the decision conveyed vide CCH's letter no. 15-1/2018-CCH(3)/18510-18768, dated 16th January, 2019 and decided by the High Court of Delhi in W.P. No. 2369 of 2019, which will be verified by the Council during next visitation while considering the matter for grant of permission for the A.Y. 2021-22.
- 8. The compliance of the full requirements of HCC (MSR) Regulations, 2013 made upto 31st December 2020 will be submitted by the college to CCH which will be verified for considering the admissions during the Academic Year 2021-22.

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

"Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act".

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take certain time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting BHMS course in Homoeopathy.

- **A. Teaching Faculty:** The College has provided list of 08 guest faculty out of which only 01 eligible as previous teaching experience of 07 guest faculties not provided.
- **B.** Miscellaneous: Form-16 for full time teachers (01) and consultant teachers not provided.
- C. Website: <a href="https://www.dhanvantaribhms">https://www.dhanvantaribhms</a> Functional but OPD and IPD data not available as checked on 18.09.2021.
- 3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, permission of the Medical Assessment and Rating Board is issued to Dhanvantari Homoeopathic Medical College and Hospital & Research Centre, Dhanvantri Campus, Kamatwade Opp. Abhiyanta Nagar, CIDCO, Nashik 422008, Maharashtra for 50 seats in undergraduate (BHMS) course for the academic session year 2021-22. The College Principal is directed to fulfill the deficiencies within 15 days and a compliance report may be provided.
- 4. All admissions in Under Graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.
- 5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.
- 6. The college has to comply with the full requirements of Minimum Standard Requirement Regulations, 2013 for conducting the course. All deficiencies observed and mentioned above which affects the performance of the academic Institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from issue of this permission letter. Compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the HCC (MSR) Regulation, 2013 and will consider admissions for the academic year 2022-23.
