At 1:30 pm we left the premises and student were instructed to reach the collage , where attendance was taken , feedback forms were given and students were told to write a detail report about today's visit .

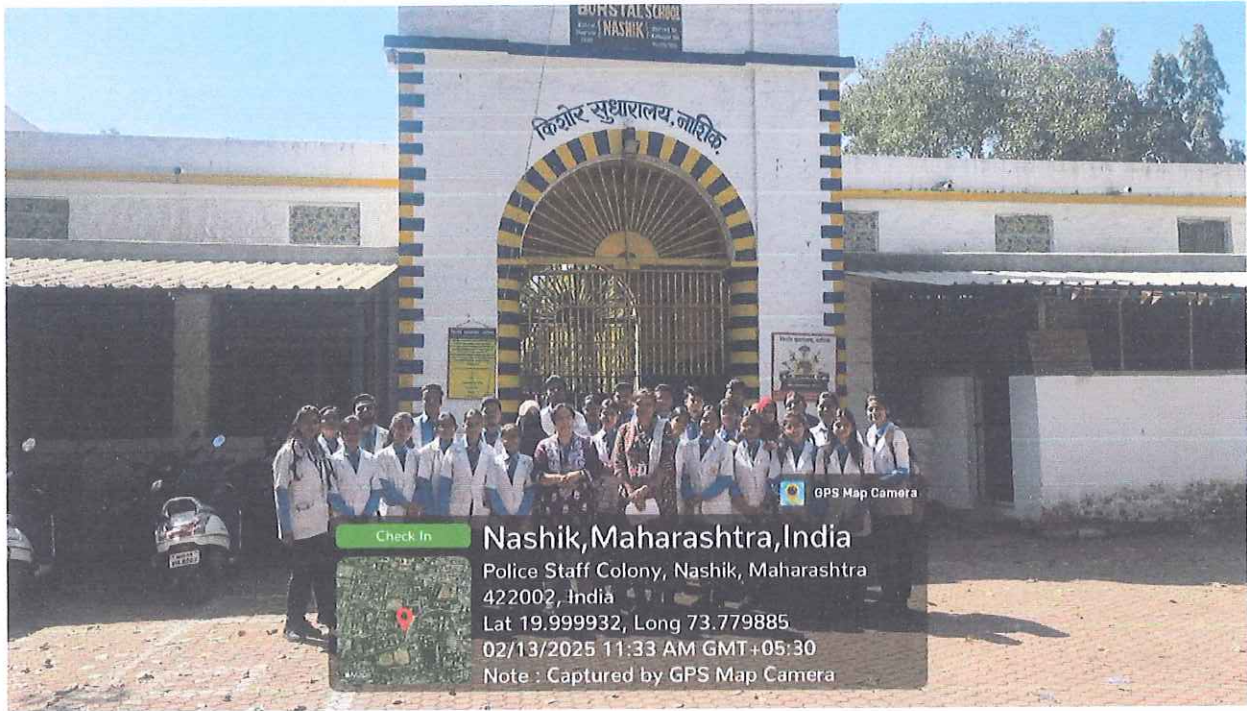

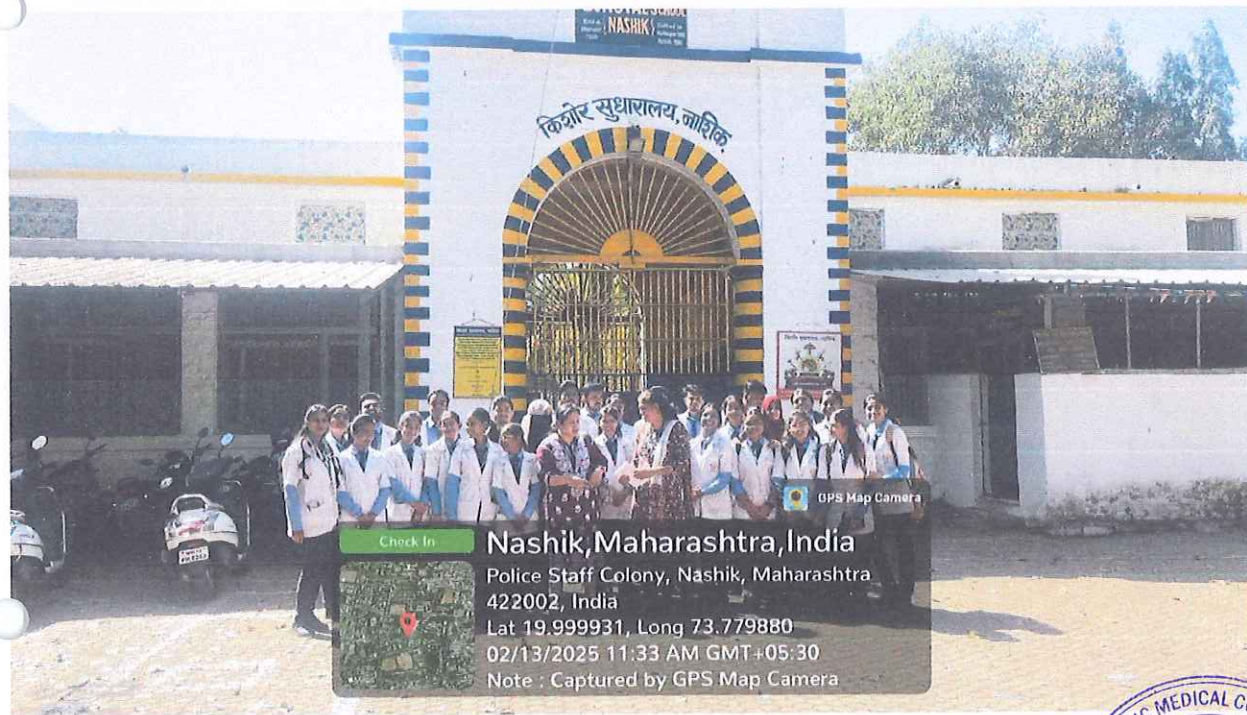

Below are the Aims and Objective of the Remand Home Visit

**Aims: Understanding Juvenile Delinquency and its Impact:** To gain insights into the causes of juvenile delinquency and understand the socio-economic and psychological factors contributing to youth behavior.

1. **Community Engagement:** To build awareness of community-based healthcare and social welfare programs that support children and adolescents in remand homes.
2. **Observing Rehabilitation and Reintegration Programs:** To explore the rehabilitation process within remand homes and the role of education, counseling, and health care in the rehabilitation of juveniles.
3. **Promoting Health and Well-being:** To assess the physical and mental health conditions of juveniles in remand homes and identify health needs, with an emphasis on preventive healthcare.



## Objectives:

1. **Health Assessment:** To evaluate the overall health status of the juveniles, including common health issues and diseases they may face, and understand the role of healthcare professionals in their care.
2. **Mental Health Evaluation:** To identify mental health challenges among juveniles, such as stress, anxiety, trauma, or behavioral disorders, and explore the role of psychological support in their rehabilitation.
3. **Understanding the Legal and Social Framework:** To understand the legal rights of juveniles in remand homes and the impact of law on their rehabilitation and social reintegration.
4. **Role of Homeopathic Medicine in Rehabilitation:** To explore how homeopathic medicine can be integrated into the overall healthcare plan for juveniles, particularly in terms of stress relief, behavior modification, and physical health improvement.
5. **Raising Awareness and Sensitizing Students:** To sensitize BHMS students to the social issues surrounding juvenile delinquency and mental health, and to foster a sense of responsibility toward community welfare and public health.
6. **Interaction with Juvenile Care Providers:** To interact with caretakers, social workers, and mental health professionals working within the remand home to understand the multi-disciplinary approach to juvenile rehabilitation.

This visit would provide an opportunity for students to connect theoretical knowledge with real-world applications in community medicine and holistic care, while also fostering empathy and social responsibility.
